County Clir Kettle – visited HS2 on 09.11.22 and was taken along the haul road (which runs from the Kineton Road, Southam, Radbourne, to the temporary Oxford Canal Bridge at Fenny Compton). HS2 will currently start building the bridge on the A423, at present they are piling. Kineton Road is due to be closed 9.00 pm – 6.00 am for topographical surveys. There will be a temporary 30 m.p.h. speed limit on the A423, on the Southam side of the HS2 site. Progress is being made with the gateways (new thinner gateway signs are now available, less than 90 cm wide).

District Clir Rock – has not received any recent complaints from Ladbroke about the 123+ bin scheme. SDC has recently released A State of the District Report. It is available to view via
