7. **District and County Councillor Reports**
District Cllr Rock advised the Covid19 vaccination programme is being organised by the Clinical Commissioning Group. The catchment area is very wide, it includes Kineton and Tysoe. Stratford District Council (SDC) are introducing a fee for green waste bins as from 1st April 2021. There is a £5 discount for those residents who sign up for the service before the end of February 2021. PC Matt Simms is moving to the Rural Crime Team, he will be replaced by PC Jamie Chilton. Inspector Alison Wiggins is also moving over to Rural Crime. SDC is currently running a Gypsy and Traveller and Travelling Shows people Supplementary Planning Document Consultation during the period 7th January 2021 – 19th February 2021. In January 2021 SDC commenced a review of its Core Strategy, working with Warwick District Council to prepare a South Warwickshire Local Plan.

20:20 hrs County Cllr Crump joined the meeting he advised the current Covid rate in SDC's area is 342/100,000, it was 42/100,000 a few months ago. The message to stay at home and not travel must be maintained. Refuse collections will continue and County Parks will be staying open. SDC have £40m available in grants for local businesses.
