**5. Public Participation**

Cllr Groves advised she has received a letter from the Millenium Trust thanking the Parish Council for the recent grant they were awarded.

Cllr Neal advised he has been in contact with Severn Trent regarding the “road works 19/20 March” signs which have arrived on Banbury Road. Cllr Neal believes these signs ought to be on Church Road. Cllr Neal has contacted Severn Trent but has not been able to resolve the situation.

**7. District and County Councillor Reports**

County Councillor Kettle advised the Parish Council the County Council has approved a 4.99% increase in Council tax, comprising 2.99% increase in general services plus a 2% increase in the adult social care surcharge. The Devolution Whitepaper - WCC has now heard back from the Minister that Warwickshire will not be considered in the first tranche of those counties being unitarized. Cllr Kettle reminded all Cllrs if they are aware of any one in the village whose child has SEND needs and are struggling please encourage them to contact him. Cllr Kettle's report was circulated to all Cllrs.

**Cllr Kettle to provide further information regarding SEND at next meeting 14<sup>th</sup> May 2025.**

District Councillor Ostrander report covered SOA District Council Budget, Devolution and Govt Reorganisation, SWLP, Community Noticeboard Grant and Community Safety. Stratford District Council Council Tax increase will mean residents will be asked to pay £169.12 for a Band D property, an increase of £5. This is an increase of 3.05%, which for an average home represents an additional 42p per month. Stratford-on-Avon remains a low-taxing authority, 18th lowest out of 164 district councils across the country in 2024/25. Although the District Council acts as the collecting agent for Council Tax, it only receives 7.1% of the Council Tax paid by residents. Warwickshire County Council receives the lion's share of 76.6%, the Police 12.8% and Towns/Parishes 3.5%. Cllr Ostrander's report was circulated to all Councillors.

10.1 There were no updates.

10.2 To discuss HS2 road closures which will impact upon Ladbroke  
Cllr Neal has been contacted by EKFB Liaison Officer advising the A423 is likely to be closed to 10 – 12 weeks from October whilst they join in the new bridge carriageway into the existing road. Following this the B4451 (road from Southam to Deppers Bridge) will then be closed for approximately 6 weeks. EKFB recognise this will impact upon Ladbroke heavily and they want to know what they can do to mitigate the issues. It was agreed Cllr Kettle will consult with the HS2 team at Warwickshire County Council regarding these closures to see what suggestions they can put forward.
